Vertu Motors plc (AIM: VTU) announces that on 11 February 2022, it purchased 30,438 ordinary shares of 10p each in the Company on the London Stock Exchange (the “Repurchased Shares”), pursuant to the share buyback programme (the “Buyback Programme”) that was announced on 05 November 2021 as follows:

The Company holds no shares in treasury.

The Company will make further announcements in due course following the completion of any further purchases pursuant to the Buyback Programme.
