The Company holds no shares in treasury.

Since the Group began Share Buybacks in October 2018, over £35.0m has been returned to shareholders, reducing the Company's shares in issue by 16.6% over the same period.

The Company will make further announcements in due course following the completion of any further purchases pursuant to the Buyback Programme.
