The Company holds no shares in treasury.

Since the Group began Share Buybacks in July 2017, over £43.9m has been returned to shareholders, reducing the Company's shares in issue by 20.3% over the same period.

The Company will make further announcements in due course following the completion of any further purchases pursuant to the Buyback Programme.
