Vertu Motors plc (AIM: VTU) announces that on 4 September 2017, it purchased 123,418 ordinary shares of 10p each in the Company on the London Stock Exchange (the “Repurchased Shares”), pursuant to the share buyback programme (the “Buyback Programme”) announced on 26 July 2017, as follows:

The Company holds no shares in treasury.

The Company will make further announcements in due course following the completion of any further purchases pursuant to the Buyback Programme.
